

The Declaration of Condominium is recorded in Official Record Book 1413, Page 1693, et. seq., as amended, of the Public Records of Sarasota County, Florida. The following amendment to the Declaration of Condominium of JACARANDA COUNTRY CLUB VILLAS, a Condominium was submitted to the entire membership of the Association at its meeting called and held on the 13th day of March, 2014, and approved by affirmative vote of not less than two thirds (66 2/3rd%) of the entire voting interests of the Association, as required by the Declaration of Condominium.


1. Article 21, Miscellaneous Provisions, Paragraph 21.15, Animals, is amended to read as follows:

21.15 Animals. No animals, livestock or poultry of any kind shall be raised, bred or kept on the condominium property, except that pet dogs; or cats or other household pets may be kept, the total of which may not exceed three (3) pets per unit, and of said three (3) pets not more than two (2) may be dogs within confined portions of the condominium units, provided that they are not kept, bred or maintained for any commercial purpose, or in numbers deemed unreasonable. No other type of household pets may be kept on the common element or within the units. The Association may adopt reasonable rules and regulations governing any pets kept on the condominium property ~~the keeping within the condominium property of such pets.~~ All animals permitted to be kept pursuant to this section shall be kept on a leash when on any portion of the common elements.






