- Grills 10:44 There was a discussion regarding the use and storage of grills. Some of the rules be in considered are as follows:
  - o Rules proposing
    - 20lb propane tanks cannot be stored within the unit.
    - If patio is sufficient size to keep grill 5 feet from opening a propane grill can be kept outside. The tanks must be stored on the grill and secured. Grills needs to be kept in good condition and covered when not in use.
    - All grilling must be done 10 feet from unit.
- Rental petition (11:17)
  - o There was a discussion regarding the Petition regarding rentals.
    - Amend document change rule to no more than two six consecutive months at a time.
    - Maximum number of rentals in the association at any time would be 7 rentals.
    - Create a waiting list to rent of owners wanting to rent.
    - Units cannot be rented with to renters with pets.
    - Aggressive behavioral dog must be muzzled at all times.
